

## **Procedure for Opening Demat and Trading Account**

How to Open a Demat and Trading Account Online with FE Securities Pvt. Ltd.

Required Documents:

1. PAN Card - Self-attested copy with signature under "Applicant Signature."
2. Signature Proof - Scanned copy of signature in black or blue ballpoint/ink pen (no markers).
3. Aadhaar Card - Submit a masked Aadhaar (first 8 digits blacked out, only the last 4 digits visible).

Download from [myaadhaar.uidai.gov.in](http://myaadhaar.uidai.gov.in) by selecting the "Masked Aadhaar" option.

4. Mobile Number - Must be linked to Aadhaar.

5. Bank Proof - Any one of the following:

- Personalized cancelled cheque with printed name.
- Bank statement or passbook with visible bank account details, logo, MICR, and IFSC code.

6. Income Proof (For F&O Trading) - Any one of:

- Bank statement (last 6 months) with an average balance > Rs. 10,000.
- Salary slip (monthly income > Rs. 15,000).
- ITR acknowledgment (annual income > Rs. 1,20,000).
- Form 16 (annual income > Rs. 1,20,000).
- Net worth certificate (> Rs. 10,00,000).
- Demat holdings statement (value > Rs. 10,000).

### **Important Notes:**

- PAN must be linked with Aadhaar, and it may take up to 7 days to update in IT records.
- Visit [ekyc.fesecurities.in](http://ekyc.fesecurities.in) to complete the e-sign process and follow the instructions provided.



**Required Documents:**

1. Application Form - Download from [fesecurities.in](http://fesecurities.in).
2. Passport-size Photo - Affix and sign across the equity and derivatives forms.
3. PAN Card - Self-attested copy with applicant signature.
4. Address Proof (Self-attested) - Any one of: Driving license, Voter ID, Passport, or Aadhaar (masked).
5. Bank Proof - Same options as online process.
6. Income Proof (For F&O Trading) - Same options as online process.

**Additional Steps:**

- In-Person Verification (IPV): Mandatory verification via webcam or physical presence.
- Submit forms and soft copies via email at [fes@fesecurities.in](mailto:fes@fesecurities.in) for review before couriering hard copies.

**Demat account Charges:**

- Individual CDSL Demat Account - Rs. 250 + GST
- Corporate CDSL Demat Account - Rs. 750 + GST
- Trading Account - No charges
